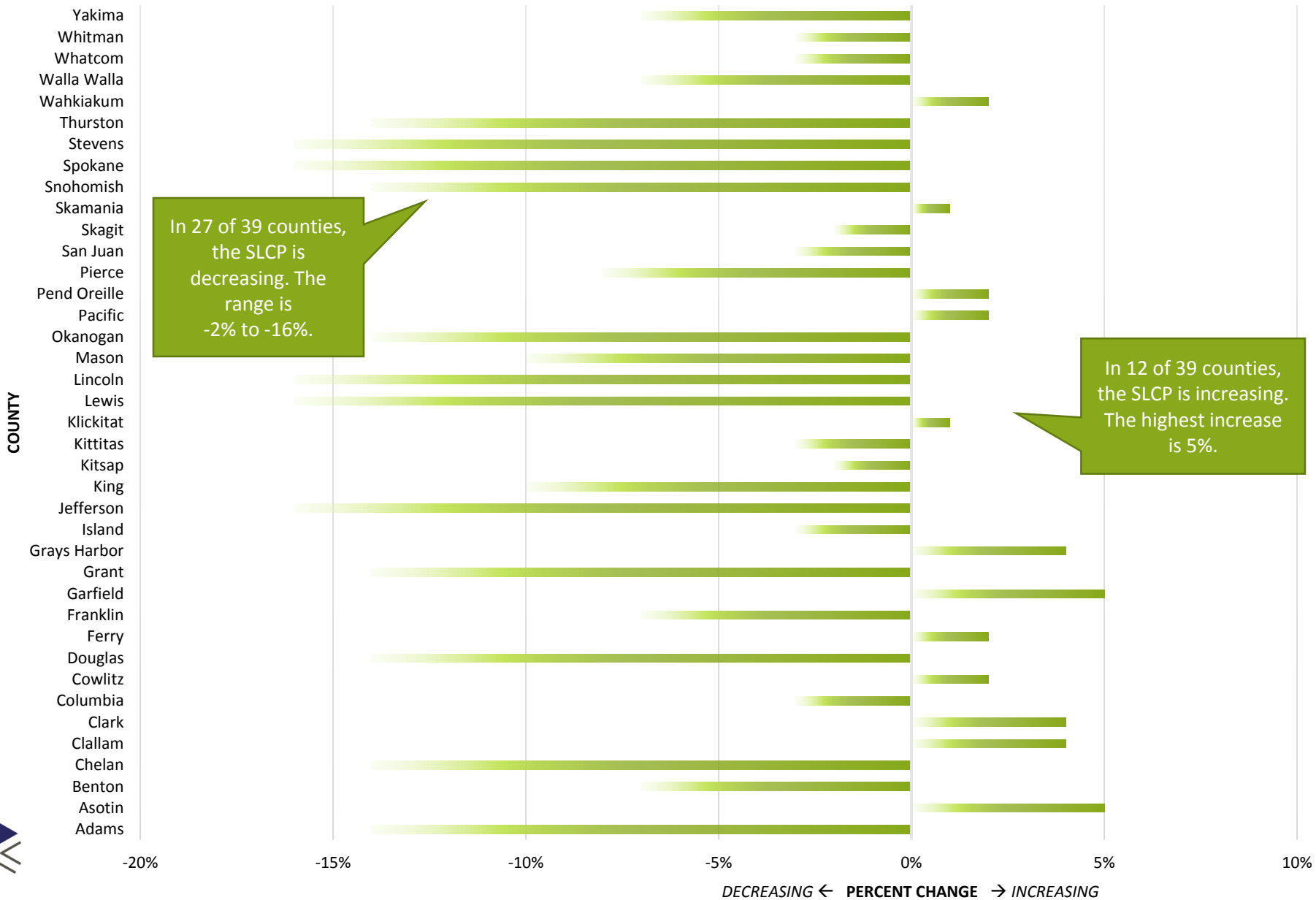
Washington Healthplanfinder Qualified Health Plan Renewals

Changes in premium prices and tax credits mean new opportunities for shoppers

- Health plans and premium prices change every year.
- The price of the second lowest cost silver plan offered through Washington Healthplanfinder is used to calculate the health insurance premium tax credit.
- The federally provided tax credit is designed to help offset the cost of health insurance premiums and is only offered through Washington Healthplanfinder.
- Health plan rates for the second lowest cost silver plans are declining in most Washington counties.
- As a result, the tax credit for 2016 will decrease for many current customers who are renewing their coverage in 2016.
- Renewing customers may find significant financial savings if they shop.
- For 2016 coverage there are more than 140 health plan options available. In many areas, lower cost options are now available.
